# 1 OVERVIEW

---

## 1.1 Overview of a Hate Crime Electronic Data Submission

Hate crime statistical reporting data may be submitted to the FBI via: (1) the National Incident-Based Reporting System (NIBRS) e-mail attachment, (2) the Hate Crime Incident Report, and (3) the Hate Crime Electronic Data Submission. This manual addresses the Hate Crime Electronic Data Submission.

After processing the hate crime data, an error list is created and returned to the State UCR Program or law enforcement agency. For summary Reporting System submissions, a text file is created.

In the Hate Crime Electronic Data Submission, the "RECORD SOURCE" (Position 2 of the record) field must contain an F.

## 1.2 Overview of Manual Sections

Section 1 is a general overview of a Hate Crime Electronic Data Submission.

Section 2 is the general record layout specification for a Hate Crime Electronic Data Submission. Section 3 is a detailed record layout specification for a Hate Crime Electronic Data Submission, which includes field formats, data validation rules, and error messages for each field.

Section 4 describes error reporting for a Hate Crime Electronic Data Submission.

Section 5 is a numerically ordered listing of all possible error messages for a Hate Crime Electronic Data Submission along with the name of the field in error.

## 2 GENERAL RECORD LAYOUT

### 2.1 Record Layout for a Hate Crime Electronic Data Submission

Hate crime records must have the file layout as specified below. The submission must be a standard ASCII text file.

If a Hate Crime Incident is sent that would fall within the quarter of a previously submitted Zero Reporting record, the existing Zero Reporting record would be automatically deleted by the FBI.

For an e-mail attachment hate crime electronic data submission, the standard ASCII text file (ex, error.txt) is created during the uploading of the data file. Upon successful completion of the upload process, this file will always contain at least one or more records, where the last record in the file will indicate that the upload data file was processed in its entirety (see below).

Each record in the file will have the layout as specified below.
